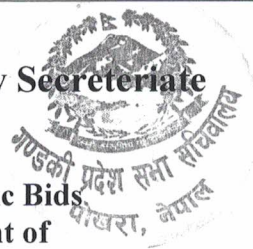

5. Pre-bid meeting shall be held at **01 June, 2026(Jestha 18, 2083) at 13:00 PM** at **Gandaki Province Assembly Secretariate, Pokhara**
6. Electronic bids must be submitted to the Gandaki Province Assembly Secretariate, Pokhara through PPMO's e-GP II system www.bolpatra.gov.np/egg on or before **12:00 hour (local time) on, June 12, 2026 (Jestha 29, 2083)**.
7. Bids shall be opened in the presence of Bidders' representatives who choose to attend at **13:00 hour (Local time) June 12, 2026 (Jestha 29, 2083)** at the office of **Gandaki Province Assembly Secretariate, Pokhara**. Bids must be valid for a period of **90 days** counting from the day of bid opening. All bids must be accompanied by bid security not less than above mention table's amount, which shall be valid for minimum 30 days beyond the bid validity period.
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original.
